## **Training Agreement**

This is an agreement between The Paws Resort & Spa, L.L.C. (hereinafter called "The Paws Resort & Spa") and the dog parent (owner) whose signature appears below (hereinafter called "Parent").

- 1. Parent has received a copy of the The Paws Resort & Spa "Training Policies" and agrees with the terms and conditions set forth within.
- 2. Parent with dog(s) participating in Board and Train has received a copy of the The Paws Resort & Spa "Lodging Policies" and agrees with the terms and conditions set forth within.
- 3. Parent agrees to pay the rates for training services (as set forth in "Training Policies") that are in effect on the date the dog participates in training programs.
- 4. Parent certifies that dog(s) will be current on all required vaccinations at the time of participation in training programs and will supply The Paws Resort & Spa with the appropriate documents and phone number of the veterinarian who administered these vaccinations.
- 5. Parent understands and agrees that in admitting their dog(s), The Paws Resort & Spa has relied on their representation that their dog(s) are in good health and have not been ill with any communicable condition in the last 60 days.
- 6. Parent certifies that their dogs(s) have not harmed or shown aggression or threatening behavior towards any person or other pets.
- 7. Parent understands that The Paws Resort & Spa reserves the right to remove dog(s) from training programs if they become destructive, overly aggressive or disruptive to staff or other dogs.
- 8. Parent agrees that any photographic images of their dog(s) taken during his or her participation in training programs at The Paws Resort & Spa may be posted on the The Paws Resort & Spa website or other The Paws Resort & Spa internet sites, or included in email or printed materials for public distribution, without prior authorization.
- 9. Parent authorizes The Paws Resort & Spa, at its sole discretion, but without any obligation to do so, to do whatever it deems reasonably necessary for the health and well being of their dog(s) during their time in training programs and Parent assumes full financial responsibility for any and all expenses involved.
- 10. Parent understands and agrees that if their dog(s) become ill or injured, or if the state of the dog(s) health otherwise requires professional medical attention, in each case, in the reasonable judgment of The Paws Resort & Spa, The Paws Resort & Spa, in its sole discretion, may engage, but shall not be obligated to engage, the service of a veterinarian, administer prescribed medicine or give other prescribed attention to the dog(s), and the expenses thereof shall be paid by the Parent.
- 11. Parent understands and agrees that if their dog(s) are not picked up by the end of the business day, The Paws Resort & Spa is authorized to take whatever action is deemed necessary for the continuing care of the dog(s), and Parent agrees to pay for any and all expenses associated with such care. Parent further agrees that dog(s) will not leave the facility until all charges are paid.
- 12. The Paws Resort & Spa shall exercise reasonable care for the dog(s) delivered by the Parent. It is expressly agreed by Parent that, unless The Paws Resort & Spa has been grossly negligent or has willfully mistreated the dog(s), The Paws Resort & Spa liability shall in no event exceed the lesser of the current chattel value of the dog(s) or the sum of \$1,000.00 per each dog(s).
